Ministerial Roundtable on Accelerating Lassa Fever Vaccine Readiness – A Strategic Moment for Regional Leadership

Lassa Fever International Conference, Abidjan

September 8th, 2025



FINAL COMMUNIQUÉ

This communiqué is issued as part of the proceedings of Ministerial Roundtable on accelerating vaccine readiness during the ECOWAS Lassa Fever International Conference, held in Abidjan, Côte d'Ivoire, from 8-11 September 2025.

Chairs' Summary

The Ministerial Roundtable on Accelerating Lassa Fever Vaccine Readiness was convened on 8 September 2025 in Abidjan, Côte d'Ivoire, under the umbrella of the Lassa Fever International Conference. At the initiative of the Government of Côte d'Ivoire, the Government of Nigeria, and the West African Health Organisation (WAHO), with support from the Coalition for Epidemic Preparedness Innovations (CEPI) and International AIDS Vaccine Initiative (IAVI), Ministers of Health from across West Africa came together to address one of the region's most pressing health security challenges. Lassa fever causes an estimated 4,000 deaths each year, costs over USD160 million annually in lost productivity and treatment, and is projected to expand in risk as a result of climate change, potentially threatening up to 700 million people.

The Roundtable gave Ministers a platform to reaffirm political leadership, agree on joint priorities, and set the course for late-stage vaccine development. They committed to mobilising and securing national, regional and global resources through a collaborative cofunding approach. ECOWAS Health Ministers also pledged to strengthen national and regional platforms for trials, laboratories, and regulatory readiness. Finally, they agreed that investments in Lassa vaccine readiness must contribute to broader epidemic and pandemic preparedness, including the 100 Days Mission. These commitments are reflected in the communiqué of the International Conference, underscoring West Africa's collective resolve to deliver a Lassa fever vaccine and to build long-term health security for the region.

Communiqué

Convening and Participation

- 1. At the initiative of the Minister of Health, Public Hygiene and Universal Health Coverage of the Republic of Côte d'Ivoire, the Coordinating Minister of Health and Social Welfare of the Federal Republic of Nigeria, and the West African Health Organisation (WAHO), with support from the Coalition for Epidemic Preparedness Innovations (CEPI) and the International AIDS Vaccine Initiative (IAVI), a closed-door Ministerial Roundtable on accelerating the development of the IAVI Lassa fever vaccine was held on 8 September 2025 in Abidjan, Côte d'Ivoire, as a prelude to the Lassa Fever International Conference organized by the Economic Community of West African States (ECOWAS),

- 4. Also participating were representatives of the West African Health Organisation (WAHO), the Coalition for Epidemic Preparedness Innovations (CEPI), the International AIDS Vaccine Initiative (IAVI), as well as technical partners and other country observers.
- 5. The remarks were presided over by the His Excellency Dr. Muhammad Ali Pate, Coordinating Minister of Health and Social Welfare of the Federal Republic of Nigeria. It featured remarks delivered by the following dignitaries:

- 6. In their remarks, the speakers recalled the objectives of the Roundtable, underscored the importance of regional solidarity, and emphasized that West Africa must seize this unique opportunity to demonstrate leadership in health security.

Burden and Rationale

- 7. The speakers also:
 - Highlighted the burden of Lassa fever on populations in the region, particularly in endemic areas: more than 4,000 deaths annually, approximately \$110 million in productivity losses, and more than \$50 million in treatment costs. They also noted that

- climate change could place up to 700 million people at risk in the future¹.
- Recalled the recommendations from the first International Conference on Lassa Fever convened by the Nigeria Centre for Disease Control in Abuja in 2019, as well as the political support expressed by ECOWAS Health Ministers at the Twenty-Sixth Ordinary Session of the Assembly of Health Ministers (AHM) of ECOWAS, held in Praia, Cabo Verde, on 9–10 May 2025, to accelerate Lassa fever vaccine development.

Deliberations

- 8. Furthermore, they:
 - Stressed that the region now stands at a critical inflection point as it enters the advanced phase of Lassa fever vaccine development,
 - Outlined the steps and the short-, medium- and long-term financial resources needed to build a complete vaccine research and development ecosystem covering the entire value chain in the region,
 - Indicated the pathway toward licensure of the Lassa fever vaccine, highlighting the key scientific, regulatory, and manufacturing milestones to be achieved,
 - Acknowledged and commended the essential role of the Lassa Fever Coalition in coordinating regional efforts toward vaccine development, as well as the recent progress made in early clinical trials and multinational studies, while noting that three other vaccines are currently in clinical development.

Political Endorsement and Commitments

- 9. In the context of vaccine readiness as a cornerstone of health security, the Roundtable recognized the crucial importance of financing, and therefore of mobilizing resources commensurate with the scale of the challenge
- 10. The Ministers expressed strong support for resource mobilization from domestic, regional and global sources to accelerate vaccine development, including through joint donor outreach and participation in regional fundraising coordination mechanisms. The Ministers agreed that domestic financing will serve as an important mechanism to be leveraged as part of the broader funding approach for vaccine readiness.
- 11. In line with the commitments made by the ECOWAS Authority of Heads of State and Government at their 58th Ordinary Session where Member States pledged substantial domestic investments to strengthen regional security and resilience the Ministers reaffirmed that financing Lassa fever vaccine readiness is integral as a pathfinder for regional collective action and long-term health security.
- 12. Beyond financing, the Ministers also recognized that to achieve the 100 Days Mission, the Lassa Fever Coalition must focus on strengthening essential core capacities, including qualified personnel for trials and laboratories, upgrading clinical trial site and cold chain

infrastructure, streamlining regulatory authorization processes, and expanding community engagement.

- 13. The Ministers emphasized the need for stronger primary health care systems to enable effective disease surveillance and ensure reliable vaccine delivery. They also highlighted the need for stronger integration of health interventions as a platform for pandemic preparedness
- 14. The Ministers assured the Director General of WAHO and the Coalition partners of their full commitment to supporting the acceleration of Lassa fever vaccine development as a strategic regional health priority and as a cornerstone of broader pandemic preparedness efforts.
- 15. The Ministers committed to adopting a collaborative co-financing approach, coordinated by the Coalition, and assured participants of their political support to sustain the momentum generated by the Conference and to elevate Lassa fever as a health priority in West Africa.
- 16. The Ministers affirmed that they would remain fully attentive to the recommendations emerging from the Conference, including those relating to the exploration of appropriate financing mechanisms, as well as those concerning coordination and the sharing of technical knowledge.

Integration with Broader Conference and Acknowledgements

- 17. The Ministers expressed their wish that this communiqué be included among the overall outcomes of the International Conference on Lassa Fever and be reflected in the final communiqué of the Conference to be published.
- 18. The Ministers expressed their deep gratitude to the Government of Côte d'Ivoire for hosting the Roundtable, and warmly congratulated and thanked CEPI, IAVI, and WAHO for their valuable support in its organization.

Closing

19. The Ministers reaffirmed that this communiqué reflects West Africa's collective resolve to accelerate Lassa fever vaccine readiness as part of strengthening regional and global health security.
